Registration is now taking place for Elementary Students Only! Download forms, complete and return to:

1. Main Office of Child Care Programs starting Monday July 19th! During office hours or you may drop completed enrollment paperwork with payment into our convenient drop slot located by the front door at anytime!
2. Evans Middle School starting Monday, July 19th through Friday, August 13th 7:30 a.m. to 6:30 p.m.
3. Walker Elementary starting Monday, July 19th through Friday, July 30th 9 a.m. to 2 p.m.

CLUB 360 Program Overview

Club 360 is an after school program developed by McKinney ISD and is located on site at each elementary campus. Staff members are employees of McKinney ISD and will serve children at a 1:15 (staff to child) ratio. Each site is managed by a Site Director, Site Assistant and Group Leaders. Holiday Care with Club 360

Care will be offered at **Minshew** and **McGowen** on designated days such as school holidays and specific days during winter break. Information will be provided on each campus at least two weeks prior to the break or on the MISD website. A separate, daily fee will be charged per child for this extra service as these days are not calculated into the regular tuition rate. ****Registration for Holiday Care is separate from regular membership.****

Enrollment

A complete enrollment packet includes:

- ❑ A registration form for each child (*download forms at www.mckinneyisd.net/departments/club360/*)
- ❑ A tuition statement signed for the child/ family
- ❑ A registration fee (**non-refundable/ non-transferable**)
 - \$50 first child/\$90 per family if paid on or before Friday, August 20th
 - If received after August 20th, the registration fee is \$100 first child/\$140 per family

Monthly tuition is assessed per child, each month. Monthly tuition is due on the 1st of each month. There is not a part-time rate for the program, although children are not required to attend every day. Monthly tuition reserves a space for the child regardless of the time actually spent in the program. All fees must be paid online, by check or money order with the Club 360 staff at the campus. **Cash is only accepted in our main office.**

A late fee* of \$20 will be assessed if monthly tuition is received on the 6th through the 15th. If monthly tuition is received on the 16th or thereafter; an additional late fee* of \$20 will be assessed (total \$40), your child will be automatically withdrawn from the program, and not allowed to return until full payment is made. **Late fees apply regardless of when the first day of the month falls or the reason it is late.*

Club 360 utilizes **Checkredi**, a check collection company that processes all returned checks. In the unlikely event that your check is returned unpaid by your bank, **Checkredi** may redeposit your check electronically and may collect a processing fee plus any applicable sales tax. 2010-2011 Registration Tuition Statement

_____ (initial) I recognize the registration fee is non-refundable/ non-transferable, regardless of the reason.

_____ (initial) I recognize Club 360 tuition is due by the first of each month and a late fee of \$20 will be assessed if monthly tuition is received on the 6th through the 15th. If monthly tuition is received on the 16th or thereafter; an additional late fee of \$20 will be assessed (total \$40).

_____ (initial) I recognize late fees apply regardless of when the first day of the month falls or the reason it is late. The late fee must be cleared by the 20th of each month in order for my child to continue 360 services.

_____ (initial) I recognize tuition is calculated based on a total for the school year and then divided out into 9 payments (September through May).

_____ (initial) I recognize all months will be charged at the same rate, regardless of the number of days within the school calendar, September through May. I do not make a payment in August or June.

_____ (initial) In the event my balance is not cleared on my account by the 20th and I do not contact the main office for a payment plan, my child(ren) will be dropped from the program (this includes tuition, late fees, late pick up fees and other fees associated with the programs). This will also affect future enrollment in any Child Care Programs service.

_____ (initial) I recognize that if I drop my child during the year from Club 360 services and then need to re-enroll, the registration fee will be charged again at the \$100 first child/\$140 per family rate and I must complete new forms.

_____ (initial) I recognize that Club 360 requires a **one week advance, written notice** in the event my child is dropping the program. The written notice must be given to the Site Assistant at the same location the child is attending or the main Club 360 office by fax or email. If notice is given after a child has dropped, full tuition will be charged for the month.
